### Things to remember on the day of your examination:

1. Arrive no later than thirty (30) minutes prior to the examination time so that you may check in and become familiar with your surroundings.
2. You must remember to bring a valid picture identification card such as your driver's license.
3. Only small purses or wallets are allowed in the examination room. No cell phones, dictionaries, reference books, briefcases, bookbags, bags, totes, palm pilots, i-pads, i-touches, or any other electronic items including, but not limited to, such as cell phones, beepers, or other communications devices are allowed.
4. We will provide No. 2 pencils for you.

*If you have not applied to enter the Court Interpreter Certification Program, you must do so before you will be allowed to register to take the written exam. Your non-refundable application fee of \$100.00 must be paid before you will be allowed to sit for the written exam.*
