**EMERGENCY CUSTODY CUSTODY CHANGE ORDER**

THIS Day this cause came before this Court and this Court finding that it has subject matter jurisdiction and fully considering the premises herein finds as follows, to-wit:

1. AMY JO TESTCASE is 11 years old, has been alleged to be an Abused and/or a Neglected Child whose resident address is 51HOLIFIELD CIRCLE BRANDON, MISSISSIPPI 39047.
2. It is in the best interest of AMY JO TESTCASE that the PHYSICAL AND LEGAL custody of AMY JO TESTCASE be removed from JILL MARY TESTCASE, the MOTHER - BIOLOGICAL of AMY JO TESTCASE and that the PHYSICAL AND LEGAL care, custody and control of AMY JO TESTCASE be transferred to ALCORN COUNTY DEPARTMENT OF HUMAN SERVICES.
3. ~~Good and sufficient cause exists to remove the PHYSICAL AND LEGAL custody of AMY JO TESTCASE from JILL MARY TESTCASE, the MOTHER - BIOLOGICAL of AMY JO TESTCASE and to transfer the PHYSICAL AND LEGAL custody of AMY JO TESTCASE transferred to ALCORN COUNTY DETENTION CENTER and there is no reasonable alternative to changing the PHYSICAL AND LEGAL custody of AMY JO TESTCASE.~~

~~IT IS ORDERED, ADJUDGED AND DECREED that the PHYSICAL AND LEGAL custody of AMY JO TESTCASE be and hereby is removed from JILL MARY TESTCASE, the MOTHER - BIOLOGICAL of AMY JO TESTCASE and that the PHYSICAL AND LEGAL custody of AMY JO TESTCASE be and hereby is awarded to ALCORN COUNTY DETENTION CENTER ALCORN COUNTY DEPARTMENT OF HUMAN SERVICES.~~

IT IS ORDERED, AND ADJUDGED ~~AND DECREED~~ that the effect of the continuation of AMY JO TESTCASE's residence within his/her own home would be contrary to the welfare of AMY JO TESTCASE and that the placement of AMY JO TESTCASE with ALCORN COUNTY DEPARTMENT OF HUMAN SERVICES is in the best interests of AMY JO TESTCASE; and, that the circumstances are of such an emergency nature that no reasonable efforts have been made to maintain AMY JO TESTCASE within his/her own home and there is no alternative to custody and the Court hereby orders that reasonable efforts be made towards reunification of AMY JO TESTCASE with his/her family.

IT IS ORDERED AND ADJUDGED ~~AND DECREED~~ , that the ALCORN COUNTY DEPARTMENT OF HUMAN SERVICES shall have complete authority to provide for any medical care or psychological care and/or treatment, for AMY JO TESTCASE, if the same should become necessary.

IT IS ORDERED AND ADJUDGED ~~AND DECREED~~ that this Order shall remain in full force and effect until further order of this Court.
