ORDER APPOINTING ATTORNEY GUARDIAN AD LITEM

THIS DAY THIS CAUSE came on to be heard and this Court having heard and considered the same finds that AMY JO TESTCASE is under the jurisdiction of this Court, that Subsection 43-21-121(1) authorizes the appointment of a Guardian Ad Litem in this Cause, Subsection 43-21-201(1) requires the appointment of an attorney to represent the legal interest of AMY JO TESTCASE and it is in the best interest of AMY JOE TESTCASE that an Attorney Guardian Ad Litem be appointed.

THEREFORE, IT IS HEREBY ORDERED that: JAMIE McBRIDE,, 215 COACHMANS ROAD, MADISON, MS 39110;(601) 573-6921, be appointed as the Attorney Guardian Ad Litem for AMY JO TESTCASE in the above styled cause.

IT IS FURTHER ORDERED THAT:

1. Upon presentation of this Order to any agency, hospital, organization, school, person or office including the Clerk of this Court, Department of Human Services, human service agencies, pediatricians, psychologists, psychiatrists, and law enforcement agencies the aforementioned shall permit the Attorney Guardian Ad Litem to inspect and/ or copy any records relating to the AMY JOE TESTCASE without consent by the AMY JOE TESTCASE or his/her/their parents;

2. The Attorney Guardian Ad Litem assigned to this cause shall maintain any information received for any such source as confidential, and will not disclose the same except in reports to the Court and other parties to this cause;

3. The Guardian Ad Litem shall, upon presentation of this Order, have full access to all evidence and reports introduced during the proceedings;

4. The Attorney Guardian Ad Litem may interview witnesses;

5. The Attorney Guardian Ad Litem shall be noticed and have the right to appear on behalf of AMY JOE TESTCASE at any hearings, interviews, investigations, depositions or other proceedings and no proceedings shall take place unless the Guardian Ad Litem accompanies AMY JOE TESTCASE;

6. The Attorney Guardian Ad Litem shall be informed of all placements of child; and,

7. The Attorney Guardian Ad Litem assigned to this Cause shall be a party to any agreement or plan entered into on behalf of AMY JOE TESTCASE.

IT IS FURTHER ORDERED that the Clerk of the Court is instructed to forward a copy of this

Order to JAMIE McBRIDE.
