FIRST CALL HEARING ORDER

THIS Day this cause came on for a FIRST CALL HEARING, with JILL MARY TESTCASE,( MOTHER - BIOLOGICAL) in attendance and before this court and this Court finding that it has subject matter jurisdiction and fully considering the premises herein finds as follows, to-wit:

1. On 08/05/2008 a petition was filed alleging in Count 1 that on or about 08/01/2008 ALCORN COUNTY, MISSISSIPPI, AMY JO TESTCASE did become an ABUSED CHILD as defined by §43-21-105(m) of the Mississippi Code of 1972, Annotated. Amy had cuts across her face and back. One or more parties present have ~~DISPUTED~~ disputed that the allegations contained in Count 1 of the petition are true and correct therein.

2. On 08/05/2008 a petition was filed alleging in Count 1 that on or about 08/01/2008 ALCORN COUNTY, MISSISSIPPI, AMY JO TESTCASE did become a MEDICALLY NEGLECTED child as defined by §43-21-105(l) of the Mississippi Code of 1972, Annotated. The cuts across Amy's back became infected and she was not taken to the doctor. None of the parties present have disputed that the allegations contained in Count 2 of the petition are true and correct. ~~DISPUTED~~ that the allegations contained in Count 1 of the petition are true and correct therein.

3. Good and sufficient cause exists to accept as well as that AMY JO TESTCASE is a/an MEDICALLY NEGLECTED CHILD as defined by §43-21-105(l) of the Mississippi Code of 1972, Annotated, as alleged in Count 2 of the petition.

~~IT IS ORDERED, ADJUDGED AND DECREED that since one or more of the parties have DISPUTED that AMY JO TESTCASE is an ABUSED CHILD as defined by §43-21-105(m) of the Mississippi Code of 1972, Annotated, as alleged in Count 1 of the petition, that this matter shall be set for a full evidentiary Adjudicatory Hearing as soon as possible.~~

~~IT IS ORDERED, ADJUDGED AND DECREED that since none of the parties present have disputed that the allegations contained in Count 2 of the petition is true and correct, it shall be deemed admitted that AMY JO TESTCASE is a MEDICALLY NEGLECTED CHILD as defined by §43-21-105(l) of the Mississippi Code of 1972, Annotated, as alleged in Count 2 of the petition.~~

IT IS ORDERED, AND ADJUDGED that the allegations contained in Count 1 of the petition that AMY JO TESTCASE did become an ABUSED CHILD on 08/01/2008 be set for a full evidentiary Adjudicatory Hearing on 9/10/08 or as soon as possible.

IT IS ORDERED, AND ADJUDGED that the allegations contained in Count 2 of the petition that AMY JO TESTCASE did become a MEDICALLY NEGLECTED on 08/01/2008 be and hereby are dismissed.
